As an applicant for Affiliate/Business Partner Membership in the Troup County Board of REALTORS®, you agree as a condition of membership that you are engaged in a specialty of the real estate profession other than selling real property, are not associated with a firmengaged in selling real property; and agree, if elected to membership, to abide by the Constitution, Bylaws, and Rules and Regulations of the Local Board, State Association, and the National Association, and Ethics of the National Association of REALTORS®, with these documents available to you at the Board office and on the website. Upon joining TCBOR, you also become a member of the Georgia Association of REALTORS® (GAR) and a portion of your dues will be forwarded to them (see chart on page 4). Once your application is received and processed, you will be emailed your welcome letter, payment receipt and a NRDS number to access both the TCBOR and GAR websites.
