- 1. NOMINEE MUST HOLD REALTOR® membership in the Troup County Board of REALTORS® and State Association January 1 to December 31, 2017, which is the qualifying period and be a member in good standing.
- 2. If selected, NOMINEE MUST attend the Georgia Association of REALTORS® convention in Point Clear, Alabama in September 2018 to represent TCBOR at the "REALTOR® of the YEAR" ceremony, at the nominee's expense.
- 3. Applicants are limited to one page for each of the categories listed below. No other narratives, resumes, booklets and documents can be submitted with this form. Signatures of Nominee and the Local Board Association Executive, Local Board/Association President or Local Awards/ROTY Committee Chairman are required. E-signatures will be accepted. Typed signatures will not be accepted.

 - a. REALTOR® Spirit –10%
 - b. REALTOR® Business Accomplishments -15%
 - c. Civic Activity –15%
 - d. Local Board / Association Activity -50%
 - e. State Association Activity -10%
 - f. National Association Activity 5%
- 5. Dates of activities must be shown.
- 6. Photo of nominee (required). Email a hi-resolution color bust photo of nominee to TCBOR by the deadline date and time. A hi-resolution photo is an image of 30+ dpi (1,000 KB or over 1 MB) resolution in a jpg, pdf, or tiff format.
- 7. Entry must be faxed or emailed to the TCBOR office 706/884-2601 by 12:00 p.m. on the deadline date. AE will email a confirmation once application is received.
- 8. ALL SUBMISSIONS MUST BE TYPED. Forms submitted with hand written information will not be considered. All applications must be signed by one of the required signatories for the Nominee to be recognized. The winner of the TCBOR ROTY award will be considered for the Georgia REALTOR® of the Year Award.
- 9. Entries received that do not adhere to these criteria will not be considered. There will be NO EXCEPTIONS made.
- 10. If you have received this award in the last 3 years, you are not eligible to apply for this local award.

The judges will be requested to consider applicant's total personality and lifestyle to ensure that the winner will be held up to the public as "the best of us." *Otherwise*, the percentage system will be strictly adhered to. Applicants may be requested to attend an interview session with selected members of the Awards Committee at the discretion of the Committee. The Awards Committee reserves the right to ask for additional information.
